#### 1. Who We Are

We are the "data controller" of the personal information you provide to us and are committed to protecting your privacy in compliance with the UK General Data Protection Regulation (UK GDPR) and the Data Protection Act 2018.

#### 2. Information We Collect

We may collect and process the following types of personal data:

- **Service Information** audio files, recordings, or notes you provide as part of our recording services.
- **Technical Data** IP address, browser type, device type, and website usage data collected via cookies or similar technologies (see our Cookies Policy if applicable).

#### 3. How We Use Your Information

We use your personal data to:

- Process and fulfil your orders, including issuing electronic invoices and enabling product downloads.
- Provide customer support and respond to enquiries.
- Deliver and improve our Products & Services.
- Comply with legal and tax obligations.
- Send you service-related communications (transaction confirmations, delivery updates, invoice copies, etc.).

We will only use your personal information for marketing with your explicit consent, and you may withdraw consent at any time.

# 4. Financial Information Handled by Stripe

We do not store your full payment card details.

Payments are securely processed by **Stripe**, our payment service provider. Stripe collects, processes, and stores your payment information in accordance with their own Privacy Policy (<a href="https://stripe.com/gb/privacy">https://stripe.com/gb/privacy</a>).

We only receive confirmation of payment, the amount paid, and limited billing information necessary for order fulfilment and invoicing.

# 5. Legal Basis for Processing

We process your personal data on the following legal bases:

- Consent for marketing communications.
- **Legal Obligation** to comply with applicable laws and financial record-keeping.
- **Legitimate Interests** for website security, fraud prevention, and service improvements.
